### **Terms and Conditions**

1. I, Renter, hereby agree to rent Owner's trailer on \_\_\_\_\_ for the amount of \$ \_\_\_\_\_.
2. I assume Responsibility for any and all damages and all bodily injury or property damage that may occur while the trailer is in my possession. Further, I agree to hold the owner absolutely harmless from any responsibility for any claim whatsoever during the time of my use.
3. I agree that any and all charges for damages to the trailer while in my possession may be deducted from my credit card.
4. I agree that any and all charges that may be occurred and not paid at drop off of the trailer may be deducted from my credit card.
5. I agree to pay a late charge of \$100. if I fail to return the trailer to owner by agreed upon return time.
6. I agree to pay a cleaning charge of \$ 25. if I fail to return the trailer to the owner as clean as it was when I picked it up.
7. I authorize any later payment of any traffic, toll or parking violation assessed against the trailer while in your possession.

### **Trailer information and instructions**

1. This trailer takes a (circle one) size ball: 1-7/8      2      2-5/16
2. This trailer takes a (circle one) electrical plug:      4-flat      7-round
3. The safety chains MUST be crossed and hooked up to the vehicle if possible.
4. When dumping the dump trailer, the gates MUST be secured and locked open.
5. Do a walk around of the trailer and check:
  - a. Coupler is hooked up correctly.
  - b. Electrical wire is plugged in all the way.
  - c. Safety chains are crossed and hooked to vehicle if possible.
  - d. All tires are properly inflated.
  - e. All moving parts are in their proper place and secured (dump bed is down, gates/doors are closed and locked.)
  - f. All cargo is properly secured in accordance with local and federal laws.
